The Daily Report presented 43 trophies last night to the nearly 100 lawyers, firms and law departments recognized during the second Southeastern Legal Awards at the Flourish event venue in Buckhead.

The awards have been presented for nearly 20 years in Georgia by Daily Report, and this year was the second year they were expanded to include the Southeast.

The honorees included attorneys, departments, firms and initiatives from Georgia plus North and South Carolina, Tennessee, Alabama and Mississippi. Managing editor Michael Mariano, senior litigation reporter Cedra Mayfield and Daily Report co-hosted the event. Though most of the honorees were <u>announced</u> in April, several categories were announced during the dinner, including Attorney of the Year, Law Firm of the Year, Most Innovative Law Firm, Best Dealmaker, Best Mentor, Best Diversity Initiative, Best In-House Counsel, Best General Litigation Department, Best Product Liability Department and, new this year, Best Young Lawyer, who was chosen from among the On the Rise group.

Attorney of the Year

<u>Sarah Jorgensen</u>, founding partner and Atlanta managing partner of Reichman Jorgensen Lehman & Feldberg, was named the <u>2024 Attorney of the Year</u>.

Daily Report's criteria, according to its call for nominations this spring, for Attorney of the Year is "intentionally broad," awarded to an attorney in the Southeast who in 2023 had the biggest impact on the law or legal community or did the most "to advance the cause of justice." Litigation Departments of the Year

Alston & Bird was named as having the Litigation Department of the Year.
